CMI's 2025 INTERNATIONAL STUDENT OF THE YEAR

Nominations for CMI's 2025 Awards of Excellence are now open. Use this document to bring your submission information together, you can then submit this information using the online nomination form.

AWARD DESCRIPTION

CMI's International Partners are a crucial part of CMI's community. The International Student of the Year award has been introduced to celebrate our learners around the world who have shown commitment to their development as future leaders, and their commitment to our vision to create better led and managed organisations.

Students are the managers and leaders of tomorrow. Instilled with an understanding of the value of management and leadership, they are on the path to inspiring and engaging the future workforce. The CMI International Student of the Year award recognises individuals who are already exceptional learners and are destined to make an impact as future leaders.

This award is for students who are registered with a CMI International Partner and are undertaking a relevant course outside of the UK. International students at UK Higher Education Institutions or training providers will not be eligible for this award, but may consider [CMI's Student of the Year Award](#) instead (see 'eligibility' for more information).

WHY ENTER THIS AWARD?

Even being shortlisted for this award will mark your students out as a future leader. Nominees and the ultimate winner will be associated with the best qualities of management and leadership. The winner of International Student of the Year will join a mutually supportive group of great students, apprentices and managers; be celebrated throughout the year across CMI channels; and have the opportunity to share insights and experiences with the wider management community. Nominees can be at any stage of their career to enter the Award as long as they meet the eligibility criteria below.

KEY CRITERIA

Nominees should demonstrate: outstanding academic achievement; strong progression on their programme; commitment to personal and professional development; impactful management and leadership capabilities. And they should be actively participating with CMI and its wider membership community.

ELIGIBILITY TO SUBMIT A NOMINATION

1. To be eligible to submit a nomination for the CMI International Outstanding Student of the Year, the nominating institution/organisation must be approved by CMI to deliver a CMI or CMI-accredited qualification ("a CMI Partner") at any time between 1st May 2024 to 1st May 2025.
2. Students may not nominate themselves.
3. International Higher Education Partners and training providers may make more than one nomination.

NOMINEE ELIGIBILITY

1. Nominees must:
 - a. Be, or have been, undertaking a CMI qualification or dual accredited qualification linked to the Management and Leadership Standards.; and
 - b. Be, or have been, enrolled at a CMI International Partner at any time between 1 May 2024 and 1 May 2025; and.
 - c. Be studying with a CMI International Partner based outside of the UK.

TERMS & CONDITIONS

1. All nominations and additional evidence should be submitted in English.
2. Each nominee will automatically be categorised by country and CMI partner region. Submissions from students registered in the UK or with UK-based CMI Partners are not eligible.
3. The overall winner will be selected from the shortlisted entries by the CMI panel of judges.
4. Only one overall winner will be awarded.
5. The shortlist will be announced in early 2026.
6. The overall winner of the CMI International Student of the Year Award will be selected from the shortlist and will be announced at an Awards ceremony in Spring 2026.
7. The winner of the CMI International Student of the Year Award will receive a trophy and certificate. These will be presented at an Awards ceremony in Spring 2026.*
8. CMI reserves the right to engage with the individual, employer or learning institution concerned to jointly promote the CMI International Student of the Year Award and the activities of both the individual and CMI.
9. The winner and CMI International Partner that submitted the nomination agree to work together with CMI to jointly promote the CMI Awards of Excellence and the activities of both the individual and the CMI.

- How the nominee shows commitment to personal and professional development
- How they're applying what they've learned in their course
- How they're demonstrating management or leadership capabilities, and making a positive impact on their employer, peers or institution
- How the nominee's activity, behaviour, skillsets showing alignment with CMI's mission, vision and values (see notes above)
